D. Certification statement and signature

This application must be signed by owner and/or authorized representative for the business, after adequate completion of this application and review by the person(s) signing below, who assumes all responsibilities.

“I have viewed and accepted all information submitted in this application to be true, accurate and complete. I consent to accept and to abide by all applicable local, state and federal regulation. I understand that falsification of any information submitted shall be cause for termination of the liquid waste transporter permit. I acknowledge that this permit authorizes the transport of only those liquid wastes listed in part B, and I understand that no hazardous waste or other incompatible wastes are to be transported or mixed with liquid waste hauled under this permit. Any person violating the applicable permit and/or local, state, and federal laws is subject to fine of \$2000.00 for each offense per day until corrective measures are taken.

FURTHERMORE, THE CITY OF PLEASANTON MAY ISSUE NOTICE OF VIOLATION, CONDUCT SHOW CAUSE HEARINGS, REVOKE THIS PERMIT, AND INITIATE LEGAL ACTIONS TO ENFORCE PERMIT CONDITIONS.

The City of Pleasanton may invoice the Permit tee for cost incurred for any cleaning, repair, or replacement work caused by a violation or discharge, and in the event that Permittee fails to make payment of any such invoice, the City of Pleasanton may suspend Liquid Waste Transporter Permit. I understand that this permit is valid for (1) one year and must be renewed on an annual basis to maintain updated information.
